



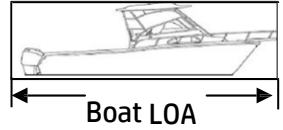

Boat Services

Spring launching and cleaning are included in winter storage.

- ____ Pickup or delivery by water (limited availability) \$100/hr/person
- ____ Shrinkwrap Removal & Disposal Flat Rate Labor \$5.75/ft LOA
Remove and dispose of shrinkwrap. Reinstall VHF antenna and outriggers as necessary.
- ____ Freshwater System Recommission Flat Rate Labor \$85 + parts
Includes flushing system & filling tank with freshwater, treating with deodorizer /cleaner, checking system operation & recommission Vacuflush head as necessary.
- ____ Check and repair boat auto bilge pump operation Time & mat. up to \$175
Repair authorization up to \$175.00 Check boat automatic bilge pump operation, repair as necessary.
- ____ Bottom repaint standard ablative paint Flat Rate Labor \$20.00/ft hull length
- ____ Bottom repaint premium ablative paint Flat Rate Labor \$25.00/ft. hull length
- ____ Bottom repaint pontoon(metal free ablative) Flat Rate Labor \$22.50/ft. hull length
Tape existing paint line, apply one coat of bottom paint and dispose of used materials.
- ____ Hydraulic Steering System Service Flat Rate Labor \$85/cylinder + parts
Disassembly, inspection, lubrication and reassembly of outboard motor mounted steering cylinder(s). Labor to disassemble seized hardware is additional. Service suggested every other Spring.
- ____ Anode replacement
- ____ Outboard anodes, bracket & lower unit Flat Rate Labor \$75single/\$125twins + parts
- ____ Outboard bracket anode Flat Rate Labor \$45+parts
- ____ Outboard internal Time and materials (estimate \$80-\$200/outboard + parts
(varies with model & type of anodes)
- ____ Battery Charge & Load Test service (est. \$50-\$130) Time & materials
Charge and load test boats existing batteries, clean connections. Remove as necessary.
- ____ Battery Replacement (estimate \$200-\$300/battery) Time & materials
- ____ Fuel tank top off Flat Rate Labor \$100+Fuel+Yamaha Stabilizer
Run boat by water to offsite local fuel dock, top off fuel tank and add summer ratio of Yamaha Stabilizer

Hauling & Associated Rates

- Labor and use of machinery are included.
- ____ Removal & reinstallation of outriggers & lines is additional \$100/hour.
 - ____ Haul/launch, forklift, block on land. Launch to water \$14.50/ Ft. L.O.A.
 - ____ Hauling/launching (at local boat ramp) to/from boat's trailer \$100/hr/person

Detailing Services

- ____ Hull Wash and Wax (rub rail down to waterline) \$14.75/ft. Hull Length Flat Rate

Engine Services

Recommission

Connect battery, test run motor on hose on land, verify throttle, shift & steering operation, water test motor (in the bay) if boat will be picked up by water. This service is performed on land, haul/launch fees may apply.

Outboard Tune Up

Replace the spark plugs and primary engine fuel filter, connect battery, test run on hose, check for fluid leaks, verify proper throttle, shifting & steering operation, water test motor (in the bay) if the boat is to be picked up by water.

Outboard 100 Hour Service

Complete once a year service. This is a 34 point check. Includes both the Engine Tune Up and Fluid Change services. Also change external anodes, comprehensive engine inspection. Includes water test if the boat is to be picked up by water. Manufacturers suggest this service every 100 hours of use. This service is performed on land, haul/launch fees may apply.

- ____ 2 Stroke Outboards Flat Rate Labor \$375 single/\$675 twins+ Parts
- ____ 4 Stroke Outboards Flat Rate Labor \$480 single/\$865 twins+ Parts

Outboard Fluids Change

Four Stroke Only, change crankcase oil and oil filter, change lower unit gear oil and drain screw washers, pressure test lower unit as necessary and change boat mounted water separator / fuel filter. This service is performed on land, haul/launch fee may apply.

- ____ Fluids Change, Flat Rate Labor \$170 single / \$300 twin +parts

Water Pump & Thermostats

This service is recommended every 3 years or 300 hours of use whichever comes first. Remove and replace the waterpump, water pump housing, thermostat and thermostat seals. Reseal the drive shaft & shift rod cover. Pressure control valve will be serviced or replaced as necessary. This service is performed on land, haul/launch fees may apply.

1. I hereby authorize the repair work described along with the necessary materials. You and your employees may operate the unit herein on any waterway or elsewhere for the purpose of testing, inspecting or delivery at my risk. I agree to be personally responsible for all attorney fees incurred by Somers Point Marina to collect any outstanding balances.
 2. RISK OF LOSS: Owner recognized that storage of Vessel, equipment and/or other items is at the Owner's risk. For Vessel's protection and owner's peace of mind, SOMERS POINT MARINA strongly recommends owner remove all valuable items from Vessel. It is expressly agreed SOMERS POINT MARINA will not be responsible for any loss, theft, destruction and/or damage of any items, nor for any loss, theft, destruction and/or other damage to Owner's Vessel or any other appurtenant to the Vessel or other equipment relating to any service provided by SOMERS POINT MARINA. Owner does hereby indemnify and agree to hold harmless SOMERS POINT MARINA, its agents, servants, employees, and representatives, from and against any loss, cost or damage resulting to Owner's Vessel and/or property, and/or other persons property. In no event shall SOMERS POINT MARINA be liable to Owners', Owner's employees, agents, servants, guests, invitees, and licensees resulting from SOMERS POINT MARINA's inability to act due to circumstances beyond the control of SOMERS POINT MARINA, without limitation, any emergency, terrorist or other situation, or any act of God.
 3. Somers Point Marina reserves the right to move the unit(s) any time within Somers Point Marina's premises and between Somers Point Marina offsite storage lots.
 4. Insurance – Somers Point Marina requires \$500,000 in Protection & Indemnity (watercraft liability) insurance including pollution liability. I agree to release and discharge Somers Point Marina from any and all responsibility or liability for injury (including death), loss, damage to persons or property in conjunction with the Somers Point Marina's facility, marina or equipment. This release and discharge shall cover without limitation any loss or damage resulting from Somers Point Marina's employees parking or hauling owner's boat, theft, fire, vandalism, hail, high/low water, wind collision, freezing, rain or any act of God.
 5. I acknowledge that Somers Point Marina has all the appropriate Maritime liens, either Federal or State, upon the boat, motor(s), and accessories thereof, to secure any and all space rental fees, repair, gas, oil, maritime hardware, accessories, or other services or materials rendered to or supplied to owner for use upon the stored boat. I agree that all charges under the terms of this agreement shall be paid promptly, net 10 days. Interest at the rate of 2% per month or fraction thereof will be charged on all past due accounts. Boats left on Somers Point Marina premises for a period of 3 months without the payment of storage or repair bills will be considered abandoned, and seizure and sale procedures will be instituted under the laws of the State of New Jersey.
 6. Due to environmental and insurance regulations:
 - a. No independent contractors, service organizations or outside individuals will be allowed to perform work or enter the Somers Point Marina facility without first obtaining permission. Permission will only be granted if the Somers Point Marina service department cannot perform said repairs. All contractors, organizations or individuals are required to provide Somers Point Marina with a certificate of insurance coverage. Said certificate shall include coverage for liability, worker compensation and name Somers Point Marina as additional insured.
 - b. Owner may perform only light cosmetic work (i.e. waxing, cleaning) on their own boat hull & topsides while it is on site at our 830 Bay Avenue location. No work is permitted at Somers Point Marina's off-site storage yards. No work is allowed on the boat bottom. Use of electrical outlets to operate power tools, equipment, machinery etc. is only allowed with written permission of Somers Point Marina.
 7. Empty boat trailers not picked up within 10 days of date of invoice and left at Somers Point Marina will be charged for storage.
 8. Idle summer long seasonal boat storage (outside) is \$40/ft. LOA. The summer season runs thru September 30, 2025.
 9. Boats not retrieved within 10 days of the service invoice date will be subject to hauling and storage charges. Boat delivery is available.
 10. In addition to parts and labor Somers Point Marina also charges a "shop/environmental fee" as part of the repair bill. This fee is to help defray the cost of certain materials, disposal of fluids & other fees that cannot be accurately itemized, but which are used in the repair & service of your boat/motor(s) /trailer. This fee is a 2% flat rate of the total of parts and labor minimum \$15 to a maximum of \$75 per work order.
 11. Rates subject to change without notice.
 12. A Spring launching cannot be scheduled unless the owner's account is paid in full.
 13. No trailer or boat may be removed from the facility until all charges are paid in full.
 14. Somers Point Marina uses typical marine hauling, blocking and trailering methods and is not responsible for damage resulting from a boat being structurally unsound for these methods of handling.
 15. L.O.A. is boat length overall defined as the measurement in feet from the tip of the bow to the center of the stern, including bow pulpits, swim platforms, motor brackets and length of the motors or outdrives in the raised position.
